Alaska Case No. 3:19-cv-00216-JWS; Ninth Circuit Case No. 20-35721) Trustees for Alaska represents Friends of Alaska National Wildlife Refuges, The Wilderness Society, Defenders of Wildlife, National Audubon Society, Wilderness Watch, Center for Biological Diversity, National Wildlife Refuge Association, Alaska Wilderness League, and Sierra Club as Plaintiffs in a lawsuit challenging the Department of the Interior's land exchange agreement with the King Cove Corporation to trade away lands within Izembek National Wildlife Refuge's designated Wilderness.

Status of the case: Plaintiffs prevailed in District Court. The U.S. Court of Appeals for the Ninth Circuit ruled the Department of the Interior's decision was valid. We filed a petition for rehearing en banc seeking to overturn that decision. We await a decision from the court.

Trustees for Alaska represents Northern Alaska Environmental Center, Alaska Wildlife Alliance, Center for Biological Diversity, Earthworks, National Audubon Society, National Parks Conservation Association, Sierra Club, The Wilderness Society, and Winter Wildlands Alliance as Plaintiffs in a lawsuit challenging approval to build a 220-mile road to the Ambler mining district by the Bureau of Land Management, the Army Corps of Engineers, and National Park Service. The suit alleges failures to comply with numerous statutes and regulations, imposing important protections for the lands, wildlife, communities, and aquatic resources of the region.

Status of the case: The Department of the Interior filed a motion seeking voluntary remand for further environmental review. The court granted the motion without vacating permits and ordered periodic status reports.
